This 47 hr. course is required by NYS as the first step in obtaining an armed guard registration card from the NYS Department of State. To attend the course, students **must** possess a valid NYS pistol license, pursuant to NYS Penal Law Section 400.00 and a valid NYS security guard registration card. The course consists of 7 hrs. of NYS Penal Law Article 35 (Use of Force / Deadly Physical Force) and 40 hrs. of intensive range instruction and qualification. The student must pass a written examination on Article 35 and qualify with a duty handgun to successfully complete the course.

### 8 Hr. Annual Firearms Training Course

for Armed Security Guards

This 8 hr. course must be completed within 12 calendar months after completion of the 47 Hr. Firearms Training Course for Armed Guards, and annually thereafter. Students attending the course **must** possess a valid NYS pistol license pursuant to NY Penal Law Section 400.00 and a valid NYS armed security guard registration card. The course consists of 3 hrs. of NYS Penal Law Article 35 (Use of Force / Deadly Physical Force) and 5 hrs. of range instruction and qualification. The student must pass a written examination on Article 35 and qualify with a duty handgun to successfully complete the course.



**DFTF, LLC** is a security guard training school (# 330815) certified by the State of New York DCJS to provide security guard instruction and certification in New York State.

Since 1995, DFTF has been established as a provider of instruction and training for security professionals. Our instructor credentials include NYS DCJS, NRA, NRA Law Enforcement and IALEFI.

Armed training is conducted at our home range of operations: Deerfield Fish & Game Club, located in Deerfield, NY.



## Refund Policy:

Any student who cancels a course before instruction begins, will receive a full refund. For courses divided between two days, the student will receive a 50% refund if requested before the start of the second day. For courses divided into four sessions, the refund schedule shall be 75%, 50%, and 25%.

Withdrawal during or for failure to complete a course after it has begun, will forfeit all tendered fees, extenuating circumstances may apply. Students enrolled in the 47 hr firearms training school will be entitled to an 85% refund if the cancellation occurs after the initial deadly physical force training begins, but before instruction begins for the firearms handling, safety, proficiency, and qualification component of the course. No refund is owed if the student cancels after the above cited firearms handling component instruction has begun.

## Attendance Policy:

Students must attend and actively participate in all sessions in order to successfully pass a course.

## Complaint Procedure:

Any and all complaints must be delivered in writing and be specific in nature. Complainant will be promptly contacted and a resolution, acceptable to both parties will be sought. If an issue can't be resolved to the satisfaction of all parties, then NYS DCJS will be contacted. Their decision will be final and binding.

## [# 700]

### 8 Hr. Pre-Assignment

#### Training Course for Security Guards \$75.00

This 8 hr. course is required by NYS as the first step to obtaining a security guard registration card from NYS Department of State. The course provides students with a general and generic overview of the duties and responsibilities of a security guard. Topics covered in this course include the role of the security guard, legal powers and limitations, emergency situations, communications and public relations, access control, and ethics and conduct. Passing a written examination is required for successful completion of this course.

### 16 Hr. On-the-Job

#### Training Course for Security Guards \$125.00

This 16 hr. course must be completed within 90 days of employment as a security guard. The course provides students with specific and detailed information on the duties and responsibilities a security guard. Topics covered include the role of the security guard, legal powers and limitations, emergency situations, communications and public relations, access control, ethics and conduct, incident command system, and terrorism. Passing a written examination is required for successful completion of this course.

### 8 Hr. Annual In-Service

#### Training Course for Security Guards \$75.00



This is an 8 hr. course that must be completed within 12 calendar months from completion of the 16 Hour On-the-Job Training Course for Security Guards, and annually thereafter. The course is structured to provide students with updated and enhanced information on the duties and responsibilities of a security guard. Topics include the role of the security guard, legal powers and limitations, emergency situations, communications and public relations, access control, and ethics and conduct. Passing a written examination is required for successful completion of this course.
